
Violations and Motor Vehicle Data

The Glen Ridge Police Department issued 2,748 traffic summonses in 2023. A total of 1207 were issued for moving violations, 1541 summonses were issued for parking violations and 11 borough ordinance violations were issued. There were a total of 3,323 traffic stops, 809 traffic details conducted and 126 vehicles towed. The department completed 7 traffic surveys and received 66 traffic related complaints which were investigated.



Traffic Crashes

The department responded to 235 traffic accidents, 63 of which had injuries. There were zero fatal motor vehicle accidents and 9 pedestrians were struck by a motor vehicle.



Traffic Officer


In August of 2023, the department was able to dedicate one full time officer to traffic enforcement. Sgt. Matthew Perigo was assigned as the traffic officer. His responsibility included responding to traffic complaints, enforcement and conducting traffic surveys. After being assigned, Sgt. Perigo conducted 563 motor vehicle stops, completed 7 traffic surveys and 177 specific traffic details. The assignment has proven to be extremely successful and has allowed the department to respond to the multitude of traffic complaints in an expeditious manner.

Traffic Grants

The Glen Ridge Police Department received three traffic grants this year for enforcement. The grants were issued through the NJ Department of Highway Traffic and Safety and were for *Distracted Driving*, *Click it or Ticket* and *Driver Sober Get Pulled Over*. Officers conducted 607 traffic stops, issued 173 summonses and two arrest were made during these details.

Racial Profiling Statistics


The Department reports on all ethnicities for motor vehicle stops. Below is a breakdown of total traffic stops and reported ethnicity.




Arrest Data


Arrestee Gender

Internal Affairs Report and Major Discipline

The Internal Affairs Division consists of Lieutenant Faranda, Lieutenant Gnardellis and Detective Sergeant Manley. The unit processed eight complaints for officer misconduct in 2023. The unit also processed two random drug tests of sworn officers in accordance with the New Jersey Attorney General Guidelines and monitored the Early Warning System for officer conduct. The Internal Affairs unit also monitors and reports to the Essex County Prosecutor's Office any Brady and Giglio violations which would result from untruthfulness.

There was no major discipline imposed on a Glen Ridge Officer in accordance with AG Directive 21-6.

Motor Vehicle Pursuits

The Glen Ridge Police Department engaged in one motor vehicle pursuit during 2023. There were 11 reported instances where a vehicle failed to stop for a Glen Ridge Officer, which fled the scene and no pursuit was initiated.

Use of Force

In 2023, two use of force reports were completed by officers for one incident. The one incident involved a mental health incident and there were no reported injuries. All incidents were categorized as physical force as defined by the New Jersey Attorney General.

There were four show of forces during two incidents where constructive authority with a firearm was utilized.

A command level review was completed for each use of force incident. There was no indication that force used was administered inappropriately.

Complaints

The Glen Ridge Police Department accepts and investigates all complaints of department and employee alleged misconduct or wrongdoing from any person, department employee or any other source, including anonymous sources. 

Detective Bureau

In 2023, the Detective Bureau, comprising one supervisor and two detectives, diligently investigated 328 incidents. The department's investigative unit made positive strides by enhancing investigative techniques and leveraging modern technology. A total of 169 cases were successfully cleared, yielding a clearance rate of 52%. While this represents a nominal decrease from the previous year, it's crucial to recognize that our focus on advanced investigative methods has yielded tangible results. Additionally, modifications to marijuana laws, as well as bail reform legislation, have had an immediate impact on criminal investigations.



One noteworthy achievement is the 6% increase in adult arrests during 2023, showcasing the department's commitment to maintaining public safety. This positive outcome attests to the dedication and effectiveness of our Detective Bureau.

Moreover, our investment in crime scene processing training has led to a notable development in the realm of open/inactive cases. The percentage of these cases has risen from 7% to 17%. This increase, while seemingly concerning at first glance, becomes a significant milestone when we consider the context.

It's important to emphasize that the 17% of open/inactive cases exclusively pertains to instances where fingerprint or DNA evidence was recovered and subsequently submitted for analysis. This strategic approach ensures that we prioritize cases with a higher likelihood of yielding results through advanced forensic techniques.

Profiles derived from this evidence are now cataloged in a national database, poised to contribute to future arrests and criminal charges. This forward-thinking initiative aligns with our commitment to staying at the forefront of crime-solving methodologies and underscores our dedication to justice.

In conclusion, while the overall clearance rate may have experienced a modest decrease, the concurrent increase in adult arrests and the proactive approach to leveraging forensic evidence exemplify our department's resilience and adaptability. We remain steadfast in our pursuit of justice and the safety of our community.



Project Medicine Drop

The department's prescription drug abuse prevention program, Project Medicine Drop, continued to grow in popularity in 2023. This proactive crime prevention program provides residents an opportunity to properly discard expired, unused or unwanted prescription medications. The department collected 213 pounds of expired, unused, or unwanted prescription medications, an increase of 22.5% from 2022. Since launching the program in 2017, the department has collected 1,533 pounds of medication.

Reassignment of Personnel

On January 9, 2023, Officer Kendall Caruso was reassigned to the Detective Bureau. Detective Caruso has been a member of the Glen Ridge Police Department since September 2001 and brings a unique skill set and fresh perspective to the investigative division. During her first year in the Detective Bureau, Detective Caruso investigated a variety of crimes, including but not limited to theft, burglary, fraud, sexual assault, extortion, weapon offenses, acts of juvenile delinquency, and domestic violence offenses. In addition, Detective Caruso has spearheaded community policing initiatives while aggressively developing the department's social media presence.

School Engagement

In addition to investigative responsibilities, the Detective Bureau served as the liaison to the school district. Detective Anthony Re was assigned as the primary school liaison to the Linden Avenue School and Glen Ridge High School. Detective Kendall Caruso was the liaison to the Forest Avenue School, Central Avenue School, and Ridgewood Avenue School. During the academic year, detectives conducted a variety of security drills and community policing programs at their respective school.

Notable Cases & Events

Motor Vehicle Theft Arrest

On January 6th, 2023, a motor vehicle was stolen from the 100 block of Forest Avenue. Det. Re and Officer Cicchetti responded to the scene and determined that the vehicle was equipped with GPS. Det. Re & and Officer Cicchetti were able to respond down to Newark in an effort to track the vehicle. They were able to locate the vehicle at the Jersey Gardens mall in Elizabeth. While observing the vehicle, they observed the suspected vehicle thief walking towards the vehicle, as they went to stop him, he took off running. Officer chased the suspect on foot through the parking lot and were able to apprehend him. It was later determined that the suspect was wanted for several home invasions in Tenafly as well as additional auto thefts.

CPR

On February 5th, 2023, Sgt. Mazza and Officer Uliano responded to Woodland Avenue for a male who was not breathing. He determined that the male was in cardiac arrest and began CPR. With assistance of an AED and after several rounds of compressions, the man was resuscitated.

Domestic Violence – Stalking

On March 2nd, 2023, Sgt. Schwartz and Officer Uliano responded to the 900 block of Bloomfield Avenue for a male who was trespassing on the property. Upon investigation, it was determined that the male was previously in a relationship with a resident at that location and had been waiting for her outside the residence. He had been previously advised he was unwanted at that location. He was also determined to be in possession of a weapon. He was subsequently arrested by Officers and charged.

Burglary to Motor Vehicles

On April 4th, 2023, while heading home after his work shift, Det. Re observed three individuals who were breaking into vehicles on Sherman Avenue. He immediately notified patrol officers, Sgt. Schwartz, Officer Waring and Det. Sgt. Manley responded to the area. They were able to locate the suspects who were observed breaking into vehicles. Two of the suspects complied with Officers directions and one fled the area. After a long foot pursuit, the suspect was captured without incident. All three were charged on a juvenile summonses and released to their family.

Burglary to Residence

On May 8th, 2023, Officer Uliano responded to Thomas Street on an in progress Burglary to a residence. He was able to obtain a good description of the suspect and broadcast it to responding units. The suspect was located and taken into custody without incident.

Structure Fire

On May 28th, 2023, Sgt. Medico, Officer Waring and Officer Ahmed responded to Willow Street for a structure fire along with Montclair Fire. Upon arrival, they observed the front porch of the residence was engulfed in flames. They immediately evacuated the residence. While awaiting Montclair fire, they were able to prevent the fire from spreading by using a garden hose. There were no reported injuries and Montclair Fire was able to extinguishing the remainder of the fire.

Burglary to Motor Vehicles

On August 9th, 2023, a resident of Outlook Place observed a male breaking into his vehicle. After calling 911, Sgt. Romaine, Officer Addu, Officer Sandoval and Det. Re responded to the area and set up a perimeter. While checking the area, Officer Addu observed the male inside a vehicle, the male promptly fled on foot through the backyard. Officers engaged in a foot pursuit and were able to apprehend the suspect at Broad and Bay Avenues. He was subsequently charged with Burglary to Auto.

Domestic Violence Strangulation

On October 8th, 2023, Det. Sgt. Manley, Officer Uliano and Officer Abrahamsen responded to an unwanted party inside the residence. Upon arrival, it was determined that the victim's ex-boyfriend had entered the residence and an argument began. The suspect then began to strangle the victim and threatening her while in possession of a knife. Officer were able to use constructive authority and ordered him to drop the weapon and two the ground. He was subsequently arrested, charged and remanded to Essex County Correctional Facility.

Burglary to Auto

On November 16th, 2023, while on patrol Sgt. Mazza heard glass break in the area of the Hillside Avenue Lot. While checking the lot, he observed broken glass on the ground and a male inside the vehicle. Upon observing Sgt. Mazza, the male fled the scene and Sgt. Mazza chased him on foot through the Bottle King parking lot and across Bloomfield Avenue where he was later apprehended. He was charged with Burglary to Auto, Criminal Mischief and Resisting Arrest.

Burglary Arrest

In December of 2023, Glen Ridge Det. Kendall Caruso began investigating two similar burglaries which occurred in town. At both scenes, it was determined that the suspect forced entry in the afternoon and ransacked the residence searching for items of value. Through investigation, a suspect was developed. That suspect was tied to the area of the burglary via a rental car which his friend had rented. In January of 2024, the suspected was charged with two counts of Burglary, Theft and Criminal Mischief. This incident remains under investigation as a second suspect is believed to have been involved.

Retirements and New Hires

Officer Anthony Rivera

This year we bid farewell to our beloved Officer Anthony Rivera. After dedicating 16 years of service to the Glen Ridge Police Department, Officer Rivera decided to retire to pursue his lifelong dream and relocate his family. His departure was deeply felt, as he was highly regarded both as an officer and as a member of the community.

Officer Rivera's journey with the department began as a dispatcher, later transitioning to roles in the Detective Bureau and Patrol Division. Among his many contributions, he demonstrated exceptional organizational skills, notably revitalizing and streamlining the evidence room—a significant undertaking. Additionally, he served as a firearms instructor, work zone safety instructor, and the department's Humane Law Enforcement Officer. Throughout his tenure, he served the residents of Glen Ridge with unwavering pride and distinction.

In his capacity as a field training officer, Officer Rivera continued to inspire and guide many of the department's current officers, leaving behind a positive and enduring legacy.

The department was fortunate to hire two excellent police officers in 2023. Officer Aly Ahmed (left) was hired by the department in April after having worked at the New Jersey Institute of Technology Police Department. Officer Aly brought with him 3 years of experience and is fluent in Arabic. Officer Elverth Sandoval (right) was hired by the department in April after having worked six years with the City of East Orange and he is fluent in Spanish.



Crossing Guard Tony Calzone

Crossing Guard Tony Calzone, an 18-year veteran of the departments crossing guards, retired this November. CG Calzone was a staple at the intersection of Linden Avenue and Hawthorne Avenue for most of his career and retired working the Ridgewood Avenue and Snowden Place Post. Unfortunately, shortly after his retirement he passed away unexpectedly. The department will forever miss him as well as the children who knew him. We remember all of his wonderful years of service keeping children safe.



Crime Prevention Update

GRPD has many established community policing programs, including home security surveys, bicycle safety and bicycle officers, coffee with a cop, and medicine Rx take back day to name a few.

In 2023, we instituted three new programs. The *Take Me Home* for at-risk individuals, which was created in 2003 by Officer Donohoe of the Pensacola (FL) Police Department, is a voluntary registration program that assists law enforcement in locating and interacting with seniors, special-needs children, and other high-risk persons. The *Blue Envelope Program* was rolled out in March of 2023 and is designed to assist drivers with autism who are interacting with the police. It provides a dedicated envelope to place their documents in and identifying information about the driver to assist with the interaction.

The Department also purchased and implemented an *Unmanned Aerial Vehicle* program. The purpose of the U.A.V. program is to assist patrol officers by providing aerial assistance when conducting a search for a suspect and a missing person. Additionally, the U.A.V. provides over watch support for all large events in town and is capable of transmitting a video feed back to the mobile command post to evaluate events in real time and deploy personnel appropriately. The department currently has one certified officer to operate the U.A.V.



Community Policing

Car Seat Installation Event – The Glen Ridge Police Department has two certified child safety seat installers. A second annual community event was held this year where car seat installations and safety checks were conducted. Additionally, residents may make an appointment for a child seat installation.

National Night Out – The National Night Out event was held at the Glen Ridge Community Pool. The event continues to be a huge success within the community. This year, the department of Homeland Security joined us to educate the community on their mission and equipment. The US Coast Guard also conducted a fly over for the event.



Bicycle Rodeo – The Glen Ridge Police Department hosted a Bicycle Rodeo at the Central Avenue School in June. Residents were encouraged to attend, register their bicycles and then put their skills to the test on our obstacle course.



Lemonade with Law Enforcement – The Glen Ridge Police Departments Detective Bureau hosted a lemonade with law enforcement at Carteret Park during the recreational summer camps.



Ashenfelter 8K – The A8K race was held on Thanksgiving Day 2022. The department provided security for the over 5,000 attendees at the event. The event remains a success and we're proud to be a part of it.

September 11th Memorial Service – The department hosted the Boroughs September 11th memorial service in front of our Police Headquarters to remember the victims of the 9-11 terrorist attacks on the 22nd anniversary.




